RESEARCH INTERESTS

My research interests include robust statistics, linear models, Data mining and performance managements. In robust statistics, specific areas of activity for me have included estimation and testing of location of heavy tails distributions. A new statistics of estimation and testing of location potentially offers great advantages over the moment estimators and t-test in current use.

In linear models, my interests include regression, variance estimation, and design of experiments, often with a view toward application in agriculture, biological and environmental sciences. My professional practice has often involved consultation on the design and analysis of real large data. In addition, I am working in nonparametric estimators for the tail of a distribution. I think this has great potential as a tool kit for classifying a distribution, so that you can use the best estimator and best test of location of population parameters

Lately, I have been working with my colleagues on development of performance plans aligned with organizational goals using BSC methodology. Also, designing of performance rating metrics and IBSC that effectively differentiate levels of performance, linking the IBSC with BSC through cascading or aggregating KPI's targets value, communicate, and reward results.
